TERMS & CONDITIONS FOR VOLUNTEER REGISTRATION

The Khelo India Youth Games (**KIYG**) Guwahati, Assam, 2020 are being organized by Sports Authority of India (**SAI**) under the aegis of Ministry of Youth Affairs and Sports, and the Host State of Assam, which may be referred to hereon in as “**we**” or “**us**” or “**our**” (as applicable), under the vertical ‘Annual Sports Competition’ of the ‘***Khelo India – National Programme for Development of Sports***’. SAI envisages to achieve the twin objectives of broad basing of sports and promotion of excellence in sports across the country through the organizing and conduct of the Khelo India Youth Games Guwahati, Assam, 2020.

For the purposes of these ‘Terms & Conditions of Volunteer Registration’ (hereinafter referred to as ‘**Terms**’), where the context so requires, “**you**” or “**your**” or “**volunteer(s)**” shall mean any volunteer registering for Khelo India Youth Games Guwahati, Assam, 2020 and registering themselves on the ‘Volunteer Registration Portal’ (hereinafter referred to as “**Registration Portal**”) as volunteer of Khelo India Youth Games Guwahati, Assam, 2020. Your registration on the Registration Portal is subject to the Terms under this Terms & Conditions of Participation. By giving your consent to these Terms, you hereby declare that you have read and agreed to be bound by the terms and conditions of volunteer registration as under and that the details that you have provided on the registration form are, to the best of your knowledge, true and correct.

Limited Liability:

In no event, shall SAI be liable for any consequential, indirect, special, incident or statutory damages, including but not limited to any claims or losses arising from any injury (physical or legal) sustained by you while performing volunteering services during the Khelo India Youth Games Guwahati, Assam, 2020.

Relationship:

The performance of volunteering services by you will strictly be on a voluntary basis and while providing such services, nothing contained hereunder shall be construed as establishing an employer-employee relationship or principal-contractor relationship or any agency or joint venture or partnership relationship between SAI and the volunteer.

No Remuneration:

In consideration for the services provided by the volunteer, SAI hereby clarifies that the volunteer will not be paid any remuneration and only an honorarium payment shall be made by SAI or any representative duly appointed by SAI or the Host State of Assam at the end of Khelo India Youth Games Guwahati, Assam, 2020. The volunteer hereby authorizes SAI or any duly appointed representative of SAI or Host State of Assam to make such honorarium payment to the bank details provided by the volunteer in their respective registration form for such payment.
